How many school counsellors were employed in your local authority area in a)2019/20, b) 2020/21 and c) the current year?

2019/2020 - 0.

End of 2020/2021 - 24.

2010/2022 - 23 as of August (hope to recruit approx. 3 more).

How many teachers does your local authority employ and how many have undergone mental health training?

As per HR report run on 20th May 2021 the Council employed 3,933 teachers.

Please note that this figure is only valid for the date of the report as this figure changes throughout the year. Also, this only includes the teachers working in schools, including all promoted posts (i.e. headteachers, deputes etc) and does not include any GTCS registered teachers on the payroll working in Head Office or in other areas of CEC, including supply.

Unfortunately, we are unable to provide you with the number that have undergone mental health training as the cost to the Council of locating, retrieving and providing you with the information exceeds the statutory maximum of £600.

Section 12 (1) of the Act does not oblige a Scottish public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the statutory limit.

Description of necessary work:

The Council does not hold any figures centrally regarding how many teachers have undergone some form of mental health training. In order to provide you with this information, it would require contacting each school, and asking them to speak to each teacher, to report on any training of this sort they have undertaken. At approximately 5 minutes per teacher, including collating this information, this equates to 19,665 minutes (327.75 hours) worth of work. Charged

at £15 per hour for staff to perform this task (the highest rate we are able to charge), the total cost of complying with your request is £4,916.25.

This sum has been calculated as follows:

3,933 teachers X 5 minutes = 19,665 minutes 19,665 minutes / 60 = 327.75 hours 327.75 hours X £15 = £4,916.25

Although we cannot provide figures for the number of teachers that have undergone mental health training, we can provide contextual information regarding mental health in schools, as below.

The Health & Wellbeing Team and Educational Psychology Team developed Moving On Coming Together (2 sessions) to support staff mental health and children's mental health and wellbeing. This was delivered to over 1000 staff in various online sessions during lockdown.

In addition, there have been a number of online Headteacher training inputs offered which look at Building Resilience during COVID times and Managing Stress and Anxiety amongst others. A new Building Resilience resource was shared with secondary schools to use with young people to support mental health and wellbeing on return from lockdown in 2020. Also, this August a new S1-S4 curriculum programme to support mental health and wellbeing will be launched called Young Minds Matter.

In addition, with regards to staff training, the following online courses have been shared with staff - essential CAMHS online training, online National Trauma Training, Scottish Government Mental Health in schools training.
