COVID-19 Absence/Attendance Codes

Scottish Government have worked in collaboration with Local Authorities to define a set of COVID-19 related Attendance/Absence codes. The codes will be made available within Click+Go, prior to the school return, to help ensure that student attendance can be recorded accurately.

The attached document explains how to map short codes in SEEMiS Click+Go New Attendance.
