Accident Date: 31/03/2022

We refer to the above and would be grateful if you would provide us with the following information:

Detail of all works taking place on Montgomery Street in Edinburgh between the dates 01/01/2022 and 22/04/2022.

The road was resurfaced in 2018 and there are no records of any road defects or remedial works in this time period. BP Pulse have been commissioned to install electric vehicle charge points on Montgomery Street, with the preliminary construction work taking place between 24 January 2022 and 04 February 2022. The electrical work to connect the chargers to the electricity network took place between 14 March 2022 and 15 April 2022. The chargers are now awaiting testing and commissioning to be added to the ChargePlace Scotland network. This is anticipated to be completed in Summer 2022 where the chargers will be made available for use by members of the public.
