Between 2013 and 2021, how many cases involving expired planning permission did CEC Planning department receive in total (including enforcement cases)?

It is estimated that to manually review a file would take on average approx. 5 minutes depending on the size of the file and amount of correspondence that would need to be reviewed. Based on the above estimate, it would take approx. 374.65 hours to locate and collate the above information.

In how many of those cases was new permission requested?

We do not have the ability to extract the information requested without carrying out a manual review of each file to see whether a new permission was requested.

The exception would be if the request for a new permission was the subject of a formal enforcement notice requiring the landowner or developer to submit a retrospective planning application under section 33A of Town and Country Planning Scotland Act 1997 (As amended). In those cases, under s.147 of the Town and Country Planning Scotland Act 1997 (As amended), the planning authority must keep a register of enforcement notices and the legal requirement is that the register shall be available for inspection by the public at all reasonable hours. Information for the period 2013 to 2015 is held in paper form and is publicly available to view at the Council offices. Information from 2015 onwards is held on the online Enforcement Register Enforcement – The City of Edinburgh Council and is publicly available. The online register contains a search function that allows enquirers to search for enforcement notices which relate to particular types of development. If you enter "section 33"in the search function this will identify the address of the notice.

In how many cases did CEC rule that no new permission was required and allow building work to progress based on the expired plans. (Please break this down into the permission being 1-3 years and 4-6 + years out of date.)

In how many of these cases was this granted for major alterations or house extensions?
