On this one, the treatment of the porch is an improvement and will be more in character with the house. We did also discuss the size and design of the dormer – this seems to be the same as before. Was that something you discussed in terms of changing the scale/ design? I know they are changing the roof pitch so there is an argument that the character of the bungalow is changing. I'm reluctantly happy with that given the mixed nature of the area but I still wonder whether the dormer will seem out of character and whether another design solution would just minimise its visual impact.
