We do not record or categorise complaints from "private renters".

However, we do have a Private Rented Sector (PRS) enforcement team who deal with a range of complaints relating to landlords, houses of multiple occupation, and the tolerable and repair standards. These complaints will come from a range of sources including tenants in private rented property, but will also include other sources such as neighbours, other family members or partner agencies. We do not categorise or otherwise separate these complaints by source; however, I have provided an overview of the complaints over the years requested in the table below.
