There is no designated "anti-idling zones" in operation.

Whether the council has a specific enforcement policy or procedure for engine idling (e.g., how long a vehicle must idle before action is taken, whether a warning is required first, what evidence is needed, etc.).

Legislation currently requires a request be made to switch off the engine. If the driver fails to switch off after a reasonable amount of time has elapsed, a Fixed Penalty may be issued. In all cases where a driver has been approached by a Street Enforcement officer, all drivers have complied with immediate switch off.

Whether civil enforcement officers or other staff are authorised to issue engine idling fines. If so, how many currently hold this authority?

Street Enforcement currently has 22 Enforcement Officer positions that are tasked with dealing with, amongst other duties, Engine Idling complaints.

The minimum idling time required before a fine or warning can be issued (e.g., 1 minute, 2 minutes).

Legislation does not provide a specific time frame to follow, simply stating that a 'reasonable' amount of time must elapse.

The number of engine idling fines that have been appealed, cancelled, or remain unpaid, broken down monthly from January 2020 to the most recent month in 2025.

The Anti-social Behaviour, Crime and Policing Act 2014 to which a Public Spaces Protection Order (PSPO) may be implemented is only applicable to England, Wales, and Northern Ireland. This City of Edinburgh Council has not considered any other legislative tools in regard to Engine Idling matters.
