Financial projections have not been produced in view that Committee has not yet taken a decision as to whether or how the proposed CPZ should proceed. A business case has not been produced; the proposal of the CPZ is based on consultation and survey data and in view of the policy objectives set out in the Council's <u>City Mobility Plan</u>.

The Council is currently conducting a satisfaction survey in areas where Controlled Parking Zones have been introduced under the Strategic Parking Review. After the survey closes on 7 September 2025, the data will be analysed and used to evaluate how local residents and businesses perceive the Controlled Parking Zones.

The Council is currently monitoring recently introduced Controlled Parking Zones to assess parking pressure and driver behaviour. As monitoring is currently ongoing, finalised data is not yet available.
