The City of Edinburgh Council does operate a shared service model for some other licence types, however the STL licensing regime is not considered suitable for such a shared service model due to the differing local STL policy's and the high level of service demand in Edinburgh. No other local authorities have approached Edinburgh to discuss such a model of service delivery, and as such, no documents, proposals or meetings have been held.
