Fee Setting and Review

• What assumptions were used when setting fees (e.g. projected licence volumes)?

The fees were calculated based on the cost of delivering the service which includes staff costs, inspection costs, administration costs of inboxes, call handling, objections, Committee costs, general administration and decision making. They were not based on a specific number as the licensing fees need to cover the costs of the service regardless of numbers of applications. The Committee report below explains that the Council expected the costs to be broadly equivalent to that of licensing an HMO and the fees for secondary letting were recommended using that as a benchmark. The Council's fee structure was reported to committee and agreed as per the following link:
