- 193 passengers in total on flight. No number of crew.
- Edinburgh International airport took decision not to allow passengers off the plane for what is now 2 hours. Being held on the aircraft pending advice from Port Health / HPT
- has had a telephone conversation with International airport.
- made a detailed assessment of circumstances on the information available. Discussed. This includes 4 persons in total formatted and felt sick on the aircraft during the flight. All were children. Two children were aged 2 years old. Two children aged 11. Three different families involved. All three families were dotted across the aircraft, families not sitting together. The country of departure is not deemed a high-risk country. It was a direct flight. No known illness at accommodation or airport of departure. No fever, diarrhoea, rash or other concern. No symptoms or concerns about Ebola, MERS, etc. No symptoms of respiratory illness. Initially suspected potential food poisoning/NV. However, all four in the party are now feeling well having landed. There was a period of turbulence during the flight which may have led to vomiting. Children were well before flight.
- sees no need to continue to detain passengers. However, will request a copy of the plane seating plan, passenger list with full contact details. Advice to be given to passengers by Edinburgh International Airport / Jet 2 about any future

illness and who to contact in that instance. Also, carrier advised to C&D the aircraft in accordance with their infection control procedures.
