The final payment notification (June 2025) of £ Value of pEPR payment 2025/26 is £17,006,000. The indicative allocation from November 2024 was £17,954,000. The updated allocation represented a 5.3% decrease for City of Edinburgh Council totalling £948,000.

The packaging EPR payment has been combined with other funding sources, primarily Government Grant, Business Rates, Council Tax and income from fees and charges, to support overall Council service provision in the current year. This provision includes the expenditure on recycling and waste services noted in the response above.
