Whereas

On the Council and the Contractor/Provider entered into Contract CT2545 (the "Contract") in April 2019 the terms of which the Contractor/Provider agreed to provide for the Council, the Services on the terms and conditions set out in the Contract.

The Council and the Contractor/Provider have agreed to enter into this Contract Variation in order to alter the Contract parameters in the manner set out below (the "Contract Variation Agreement").

Now it is hereby agreed:

1. Variation to the Contract:

- 1.1. Mimi's shall, on occasion and if agreed run seasonal mobile facilities for the City of Edinburgh Council in other arts or commercial venues which we operate.

1.2. The revenue for these services, payable to the City of Edinburgh Council is 15% of the sale of food and drink by Mimi's in those venues.

1.3. Both parties recognise that the rebate [REDACTED]

This Contract Variation Agreement, including the Schedule, shall be appended to the contract.

All other cost, terms and conditions as applicable to the original contract agreement and subsequent amendments will remain unchanged during the extension period.

This Variation Agreement and any dispute or claim arising out of or in connection with it or its subject matter shall be governed by and construed in accordance with Scots Law and subject to the exclusive jurisdiction of the Scottish Courts.
