Yes. Our Antisocial Behaviour Policy states – “to encourage reporting of Hate Crime, a number of Third-Party Reporting Centres are being established across community-based locations in Edinburgh, including local Council neighbourhood offices. Victims of Hate Crime are encouraged to report their experiences at those Centres using the Third-Party Reporting facility. The Centres will include dedicated staff members who are especially trained to receive reports of Hate Crime in a sensitive and professional manner. The Centres will provide assistance and advice to victims and ensure that they have access to appropriate support services.”

In terms of Education, schools would report potential incidents of Hate Crime to Police Scotland.
