Morning [redacted],

I'll let [redacted] feed into the Terminal V query, as he's been to the recent EPOG.

The red cases will have been put in late by the Licensing Service. We are supposed to be given 21(?) days to respond, however, on the APP system, once they put it on, the action log auto populates with the date we're supposed to respond by. But Licensing may not send it on to us immediately because e.g. they are still waiting for more info from the applicant, or clarification for something. So, we regularly get consultations put into the

ACE account that only have a day or two to respond within their time frame or even it's put in well after their timeframe has passed, so it has already gone red. That's why I always change the "scheduled" date to the date we respond on, so it doesn't look as we're the ones who were late.
